Make this School Year the Best One Yet!

Independent & Successful Students with Learning Disabilities

Build Open & Positive Relationships: Opening the lines of communication with teachers, principals & counselors early will lessen misunderstandings:

- Send teachers an "Introduction Email" prior to the start of the year explaining your child's strengths and weaknesses. Express your interest in supporting your child & his teachers to ensure an independent and successful year.
- Ask teachers, "What are your top three priorities for my child this year?" Discuss priorities and academic expectations with your child.
- If your child has an IEP or 504, set up a meeting to review it in person with all teachers.
- Provide teachers with a packet of information about your child's disability. (Email PC READS for a dyslexia-specific list.)
- Encourage your student to be a self-advocate. Role play at home.

Organize Your Student & Yourself: Trouble with organization and time management is usually the first thing that gets in a child's way at school.

- Consider color-coding student materials by subject.
- Begin a binder or folder at home for school paperwork and work samples. If considering a 504 or IEP evaluation, keep a homework log (time spent & help needed) and many work samples.
- Try to be home after school for the first few weeks to establish school year routines.

On Thursday, May 21st PC READS hosted, "ALL ABOUT 504 PLANS"

Many topics were covered including the process for obtaining a 504 Plan, preparing for a 504 Evaluation, accommodations & modifications to include in a 504 Plan and steps to take if a 504 Plan is denied. A few of the specific points discussed included:

- A medical diagnosis is not required for Section 504 eligibility.
- "Substantially limits" is not specifically defined by the Office of Civil Rights and should be considered broadly.
- The use of mitigating measures, including assistive technology, cannot prevent a student from obtaining a 504.
- Grades are only one consideration and academic success does not necessarily mean that a student isn't substantially limited in a major life activity; grades alone do not indicate effort or outside resources required.
